- Recognized degree with relevant engineering academic qualification plus 2 years' post degree responsible experience, or
- 1 year's Engineering Technician (Eng Tech) status plus recognized training and 2 years' responsible position equivalent to I Eng, or
- 2 years' valid AMHKIIE membership plus recognized training and 3 years' responsible position equivalent to I Eng, and
- Approved by the Council.

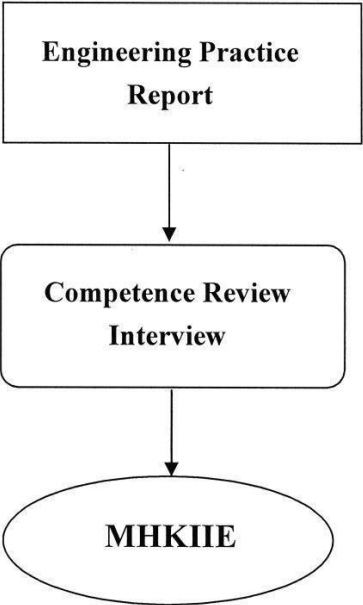

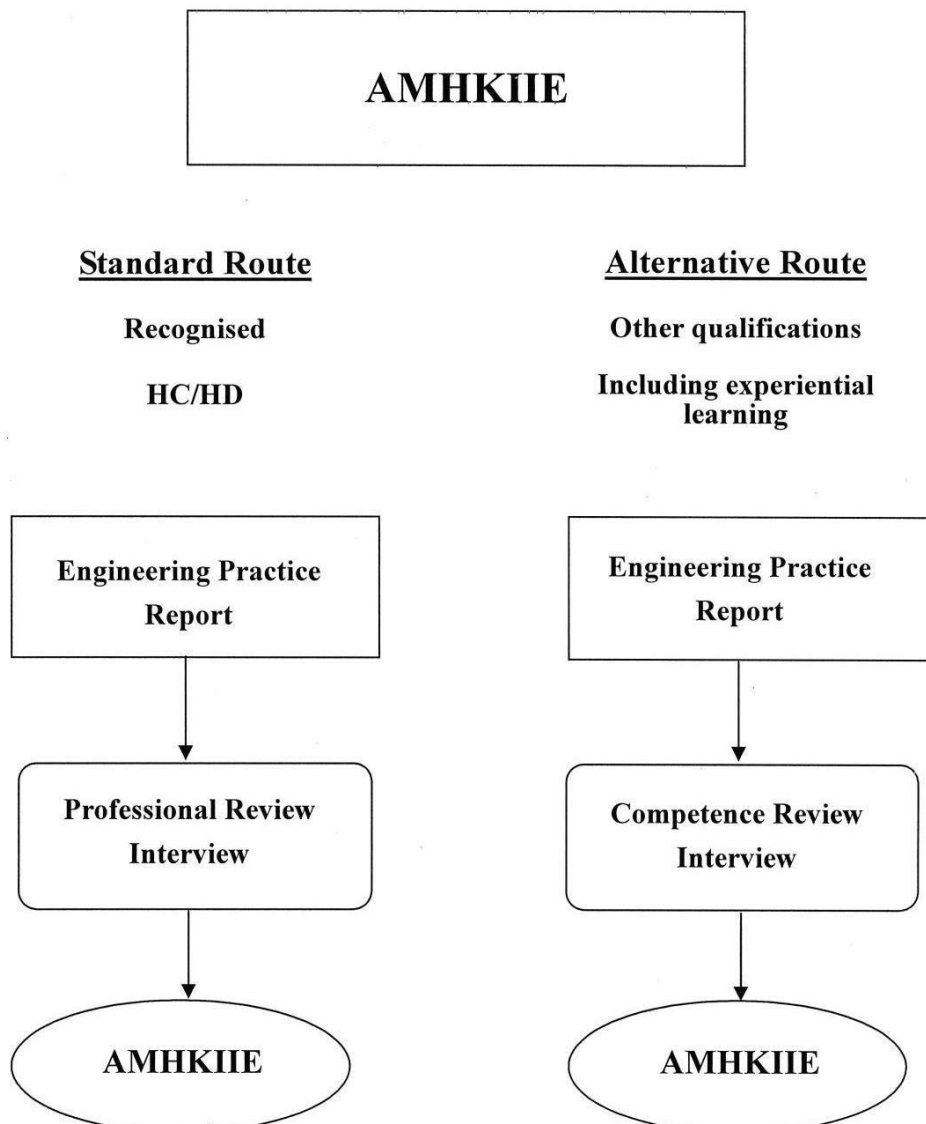


Technician Member (TMHKIIE)

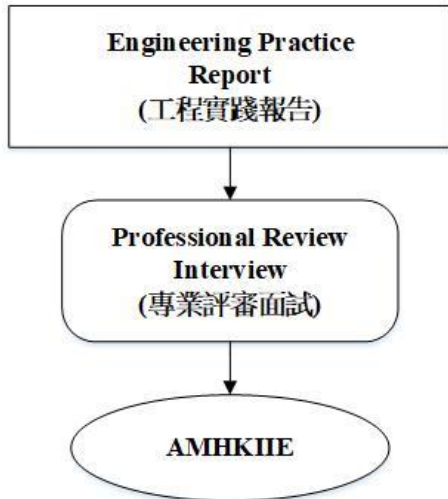

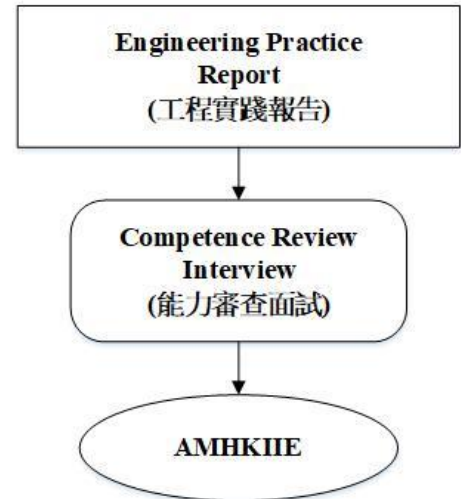

Member retiring from the practice of his profession or business

2. Any member who has retired, at the age of 60, from the practice of his profession or business, and is not in full time employment, may apply to the Council to pay a life membership subscription of amount \$500 and can remain using the entitled designation of the HKIIE with respect to the class of membership after paying the retired rate.

Honorary Secretary

Honorary Treasurer

Responsible for preparation of budget, control of finance and stock-taking of the assets

Honorary Advisor

The Council may, as recognition and by a simple majority, award any individual who has, in the opinion of the Council, given such specialist knowledge or expertise service to the support or development of the Institution. The Roll of Honorary Advisor shall be a fixed term of 2 years subject to further renewal.

Under very special circumstance, the Council may, as recognition, award any individual Honorary Advisor who has, in the opinion of the Council and supported by at least 2 Honorary Fellows, given such continuing support and distinguished service to the development of the Institution with significant achievements. The Roll of **Life Honorary Advisor** shall be a life term.

Honorary President

The Council may, as a special honour and by a simple majority, award any individual who has, in the opinion of the Council, given such significant support, outstanding contribution to the profession or distinguished service to the development of the Institution. The Roll of Honorary President shall be a fixed term of 2 years subject to further renewal.

理事會可以根據簡單多數的意見，以特殊榮譽的方式向在理事會認為對專業提供重要支持、杰出貢獻或對機構發展有卓越服務的個人頒發此榮譽稱號。名譽會長名冊的任期為2年，可以進一步續任。
